## Director of Kew Gardens talk

In June, Richard Deverell, Director of Kew Gardens, addressed a packed room of members and their guests in the impressive surroundings of Cambridge Cottage, Kew Gardens. Moving from being a former Trustee of the Gardens to his current role explained Mr Deverell, has given him a unique approach to his new post. He is looking to rejuvenate the visitor experience at Kew and ensure that it is distinct from that of any others available. Mr Deverell is keen to develop an experience that is more clearly science-based and enables visitors to more easily engage with plant science. As part of the desire to maximise all that the Gardens have to offer, he is also planning sensitively those parts of the Gardens that today stand in need of improvement. Listening to Mr Deverell talk, it is clear that the Gardens will have an exciting future in his hands and we thank him for such an interesting talk.

## Brentford FC

Brentford Football Club's application for a new 20,000-seat stadium, plus 910 flats and a hotel, on Lionel Road still has to be considered by Hounslow

Council's Planning Committee, so there is still time to object.

Whether or not you are a football fan, if allowed in its present form - this development would have a serious long term impact on Kew.

Inadequate improvements to public transport are proposed and provision has been made for only 835 parking spaces for the stadium, hotel and flats. On match days it is forecast that over 3000 cars will be looking for somewhere to park in the neighbourhood. Traffic will also be affected and, with simultaneous events at Twickenham or Wembley (plus the Kew Gardens visitors), West London could be gridlocked. To make matters worse, on match days the Club plans to close Lionel Road, the slip road to the M4. For a weekday evening match the position would be even worse.

Most alarming is the "enabling" development of flats (the profits from which, over a 10 year construction period, fund the stadium). This not only breaches planning rules with its density but the 17 storey blocks will loom over Kew Green and Kew Gardens, causing permanent harm to the local conservation areas and UNESCO World Heritage site.

## Richmond Heathrow Campaign Update

The Davies Commission on UK airport capacity has now received all the proposals for solutions to the problem of UK airport capacity. It's working now on short-listing those it thinks are the front runners.

It's a crucial stage in one of the most important investment decisions for the UK. Get it right, and the UK keeps its competitive edge without increasing the misery for millions from noise and pollution. Get it wrong and the UK loses competitive edge and jobs, and makes things worse for the environment.

A wide range of solutions are proposed from a brand new-super hub airport in the Thames estuary to dispersal of capacity either across airports in the South-East or a re-balancing to the Midlands and North. Arguably the most radical solution is from the Richmond Heathrow Campaign: don't think new runways, think passengers numbers and better use of existing runways.

The Campaign is now finalising a paper on noise and is also analysing the proposals from the main contenders for short listing to identify the common themes and the questions the Commission should now be asking itself. Do we need to invest in new runways at all? What weight should be given to minimising noise impacts, to minimising pollution, to using air transport to spread regional growth more evenly?

## Kew Pier Rubbish Bins

In 2009 the Kew Society engaged with the Council in improving the Pier environs. Many of these works were very successful but the outcome of the relocation of the pier/ferry operators' private refuse bins into the public towpath domain has been less satisfactory. First impressions for towpath users and visitors to Kew Gardens from the Thames ferry have all too frequently been very poor in terms of cleanliness and public health whilst the setting of the "key & lock" public artwork has been damaged. The Committee has resolved to engage again with the Council to return the bins clearly to private stewardship in order to restore and preserve the unique rustic character of the towpath and ensure that reduced costs fall on the community.
