**TRUSTEES' REPORT**  
**FOR THE YEAR ENDED 31 JULY 2024**

---

The Trustees present their annual report together with the financial statements for the period 1 August 2023 to 31 July 2024. The Trustees confirm that the Annual Report and financial statements of the Charitable Incorporated Organisation comply with the current statutory requirements, the requirements of the CIO's governing document and the provisions of the Statement of Recommended Practice (SORP), applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) as revised in March 2018.

### **OBJECTIVES AND ACTIVITIES**

The general objective of the charity is to maintain and enhance the area of Kew and the area immediately adjacent.

The Trustees have given due regard to the public benefit guidance published by the Charity Commission in accordance with section 17 of the Charities Act 2011.

### **ACHIEVEMENTS AND PERFORMANCE**

Incoming resources during the year amounted to £11,302 (2023: £10,206). Resources expended on charitable activities in the year totalled £11,584 (2023: £10,003). There was a net deficit for the year of £145 (2023: net surplus £203).

### **STRUCTURE, GOVERNANCE AND MANAGEMENT**

The Charity is constituted as a Charitable Incorporated Organisation, and is therefore governed by its Constitution. The Charitable Incorporated Organisation was incorporated and registered as a charity on 12 May 2017 (registered number 1173016).

The Charity's affairs are conducted by the Trustees who meet regularly and have the power to appoint new Trustees at their discretion. New Trustees appointed in this way must put themselves forward for reappointment at the next Annual General Meeting of the Charitable Incorporated Organisation. Trustees are required to familiarise themselves with the guidance provided to Trustees by the Charity Commission but the charity does not have any formal programme for the induction and training of new Trustees.

### **RISK FACTORS**

The Trustees have carried out a risk assessment and this is reviewed on a regular basis throughout the year.
